

VENTUREST PRIVACY POLICY

1. INTRODUCTION

2. INFORMATION WE COLLECT

2.1. Information You Provide Directly

We may collect the following personal data from you:

- Contact information (name, email address, phone number, address)
- Account information (username, password)
- Payment information (credit card details, billing address)
- Business information (company name, position)
- Messages sent through contact forms or email
- Survey responses and feedback

2.2. Automatically Collected Information

When you visit our Site or use our services, we may automatically collect the following information:

- IP address and location information
- Browser type and version
- Operating system
- Referring URL
- Site navigation information
- Date and time of site visits
- Device information
- Data collected through cookies and similar tracking technologies

3. USE OF DATA

We use the personal data we collect for the following purposes:

- To provide and manage our services to you
- To create and manage your account
- To respond to your requests and questions
- To send you informational, marketing, and promotional content (if you have given permission)
- To improve and customize our services
- To ensure the security of our Site and prevent fraudulent activities
- To fulfill our legal obligations
- To conduct analyses and generate statistical data

4. DATA SHARING

We may share your personal data with third parties in the following situations:

4.1. Service Providers

We may share your personal data with third-party companies and individuals who provide services to us (such as data analysis, payment processing, customer support, email delivery, and hosting services). These third parties can only access your data for the purpose of performing specified services and cannot use it for other purposes.

4.2. Legal Requirements

We may share your personal data to comply with a legal obligation, protect Venturest's rights or property, protect personal safety in emergency situations, or provide protection against illegal activities.

4.3. Business Transfers

In the event of a company merger, acquisition, or asset sale, your personal data may be among the transferred assets. In this case, we will inform you and provide options regarding how your data will be used by the new owner.

5. DATA SECURITY

We take appropriate technical and organizational measures to ensure the security of your personal data. These measures include encryption, secure servers, regular security assessments, and access control. However, please remember that data transmission over the internet or electronic storage is not 100% secure.

6. DATA RETENTION

We will retain your personal data for as long as necessary to provide our services or to fulfill our legal obligations. When there is no longer a legitimate reason for keeping your data, we will securely delete or

anonymize it.

We use cookies and similar tracking technologies on our Site. Cookies are small text files placed on your device by your browser. We use cookies for the following purposes:

- To provide site functionality
- To remember user preferences
- To analyze site traffic
- To improve user experience
- To measure marketing effectiveness

If you do not wish to accept cookies, you can change your browser settings to block or delete cookies. However, please note that some parts of our Site may not function properly in this case.

8. YOUR RIGHTS

Under applicable data protection laws, including the Personal Data Protection Law No. 6698 (KVKK), you have the following rights:

- To learn whether your personal data is being processed
- To access your personal data and obtain a copy
- To request correction of inaccurate or incomplete personal data
- To request deletion of your personal data
- To object to the processing of your personal data
- To request data portability
- To withdraw your consent
